

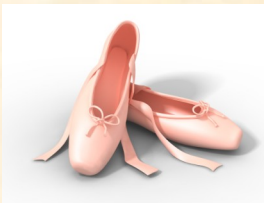

## Recital/Costume Fees

Included in this billing is tuition for December as well as costume fees for those classes required to purchase more than one costume. This is the final costume fee, with exception of those Seniors, who wish to be included in the Senior Routine at the end of the dance year. The final costume fee is due December 1, 2010. Costumes cannot be ordered for unpaid accounts, so please make sure your account is paid up to date. Costume fees are non-refundable. If you cannot bring your account up to date by 12-1-10, please contact Rebecca to set up a payment plan.
